Chairman's Award of Recognition

The Chairman's Award of Recognition was created to honour an individual affiliated with the Association, making an outstanding contribution to the general contracting industry.

Criteria

Individuals must have contributed to the General Contracting Industry in general and specifically to the Ontario General Contractors Association (OGCA), through their involvement on the Board of Directors, Standing or Ad-hoc Committees and/or any other stakeholder Committees.

Jock Tindale Memorial Award

The Jock Tindale Memorial Award to honour an individual in the industry who has demonstrated a high standard of ethics and integrity in dealings with industry participants.

This award is dedicated to the memory of John William (Jock) Tindale who served on the OGCA Board of Directors from 1983 to 1996, and as Chairman in 1992 - 93. Due to his tireless commitment to ensuring that the general contracting industry was continually striving for the highest standards of ethics and integrity, Jock was recognized and widely respected by all industry stakeholders. This award ensures that the commitment to keeping these goals are continuously alive and flourishing in the general contracting industry.

Criteria

- Individuals must have served in a senior management capacity in the industry for at least ten (10) years.
- The individual is to be known for a high standard of ethics and integrity in dealings with all construction stakeholders.
- Involvement in local, provincial, or national construction association, or community service (service club, school, church, charitable institution, etc.) will be considered.

Please note that the Selection Committee may vary these criteria in special circumstances.

Nominations

Application forms will be accepted from:

- any ICI construction industry stakeholder

Upon request, the nominated candidate may be asked to provide a list of references (owners, consultants, subcontractors) with whom he/she has worked for at least 10 years.

Judging Procedure for the Chairman and Jock Tindale Awards

Nominations will be reviewed by the Executive Committee. The Committee will determine whether an award will be presented in any given year based on the nominations received. Selection decisions will be based on information provided on the Nomination Form and/or information in OGCA records.
